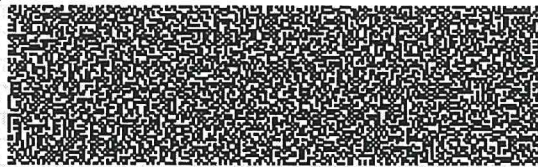
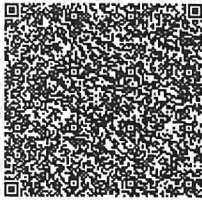



9. The following action plan be taken:
