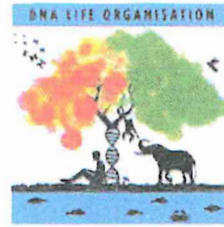

CLAUSE 6
RELATIONSHIP BETWEEN THE PARTIES

- 6.1. During the tenure of the MOU both parties will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for the purpose other than in accordance with this MOU.
- 6.2. Both Parties shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third party without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or Projects.
- 6.3. Further both parties shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.
- 6.4. CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to parties collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronic, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:
- (a) Is or becomes publicly available through no fault of the receiving party,
 - (b) Is already in the rightful possession of the receiving party prior to its receipt of such data or information;
 - (c) Is independently developed by the receiving party without reference to the confidential information of the disclosing party.
 - (d) Is rightfully obtained by the receiving party from a third party or is in the public domain.
 - (e) Is disclosed with the written consent of the party whose information it is, or
 - (f) Is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.
- 6.5. It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.




