Whereas, the first party is a deemed university accredited “A grade” by National Accreditation Assessment Council (NAAC) with Yenepoya Medical College being one of the constituent colleges, hereinafter called YMC, engaged in the treatment of patients, teaching, research and service.

Department of Community Medicine under YMC is an undergraduate and postgraduate training department involved in community-oriented training, research and service to the community. The department is also providing promotive, preventive and curative health services to the community through different tiers of health care delivery systems. It caters to the 1 lakh population. Priority research areas include operational research in tuberculosis, non communicable diseases, and maternal child health including adolescent health.

Department of Community Medicine will be the coordinating department from the first party.

Whereas, the second party is a Public Healthcare Organization working with Governments, United Nations and Institutions of Education excellence in furthering healthcare agendas and achieving the United Nations Global Goals.

In order to facilitate community development initiatives and public welfare through professional and scientific services, Yenepoya University, Mangaluru, and CHD Group, Mangaluru agree to enter into a memorandum of understanding (MoU) on following articles:

1. Capacity Building of Interns and service in community welfare and developmental activities. Interns will be posted by rotation (every 2 weeks) for these community outreach activities.
2. Second party will ensure training, logistics for the outreach and safety of the interns.
3. Mobile health camps: - Interns will participate in the mobile health camp strictly under the close supervision of the registered medical practitioner from second party.
4. The second party will pick up the intern from the university and the intern will be dropped back to the university after completion of the day's work. The deputation of interns will be only from Monday to Fridays. There will be no program held on all government holidays.
5. Any research or guidelines coming out of this activity should be credited to Department of community medicine, Yenepoya medical college, Yenepoya (Deemed to be University) Mangaluru.
6. Explore the possibility of organization of joint academic and scientific activities such as short course, workshop or any courses related to healthcare.
7. Explore possibility of community service & research collaboration in other areas between the two institutions.
8. Signature of this MoU shall not cause any obligation for either party or enter into any specific agreement relating to cooperation between two institutions.
9. In case that research result impacting upon matters of intellectual property rights are expected to arise in the course of collaborative projects within the scope of this protocol, the parties shall enter into an additional protocol governing the conditions regarding the treatment of intellectual property rights arising, prior to the start of the collaborative project in question.
10. This MoU shall be in effect for six months following the date of signature. This protocol may be complemented or amended by the written and common consent of authorized representatives of both institutions and additional protocols to this protocol. The

addendum or amendments will not be valid unless it is written and signed. The MoU may be extended for another two years by written and signed consent of the parties.

11. Each organization shall reserve the right to terminate the MoU by issuing a written notice one month in advance to the other party. Efforts will be made to ensure completion of existing projects.
12. This is a legally non-binding agreement which outlines an intention to promote community service and research collaboration between the two institutions without any financial commitment.
13. This MoU shall become effective after signing by the authorized representatives of both the institutions.

MOU/ Expression of Interest

1. This Memorandum of Understanding is being executed on 12th Sep 2019 between **M/s Knowledge Solutions India/A Microsoft-AEP (Authorized Education Partner)** having its registered office at 2nd Floor Ghyanshyam Park Housing Society, Dhole Patil Road, Pune 411001 and represented by Mr. **Sandeep Giyyan Jethani (Director Operations)** hence for purpose of MOU known as 'Delivery Partner' and Yenepoya Institute of Arts, Science, Commerce & Management represented by **Dr. Parvadhavardhini Gopalakrishnan (Principal)**, hence for purpose of MOU known as 'Resource partner / College'.
2. Delivery Partner would be offering International Certifications to the interested students from different vendors @ academic discounted price and those students who voluntarily pay the exam fees would be getting bundled training free of cost mapped to the certifications.
3. This contract in no way creates any financial binding nor does it imply that 'resource partner / College' has committed to provide any fixed number of student's registrations per year for the certification exams /bundled workshops, the only commitment from their end is to provide platform to address students / seminar to educate and motivate them about the various certifications and subsequent permission for registering the students who are voluntarily interested in the same in online/offline mode.
4. As part of the special offering all exam vouchers provided to the students for certifications would have a **second attempt bundled** in case the student fails to clear the same in first attempt in Rs. 399/- + GST
5. Delivery Partner would bundle a '**free of charge**' faculty development Program as per the availability of the Trainer/Industry Expert once a year for the faculty members of the **resource partner / College**.
6. **Delivery partner would also sponsor certification vouchers for the faculty member's equivalent to 10% of the total students enrolled in one academic year.**
7. Students would be registering directly for the certification exam by making payment to the SPOC appointed by the **resource partner / College** or with M/s (Knowledge Solutions India) either online or offline. Proper receipts would be issued for the same. In case if only the **resource partner / College** collects the payments, the same would have to be transferred to **delivery partner** max within 7 days, as exam vouchers can only be registered once payment is made. Students would be receiving a conformation mail of their voucher being booked and entitlement to free training/workshop, once they register either online or offline.

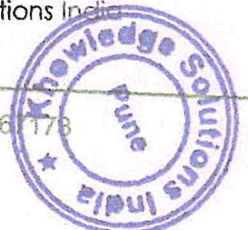

8. Earlier the MOU will be signed on name of ATS Learning Solutions/ KSI, from June 2019 onwards for all Maharashtra region the payment is made in favor of Knowledge Solution India and all the MOU's will be signed on same name.
9. The fee charged is against Microsoft /other vendor Certification exam and all other services like training are complimentary / bundled free and cannot be linked anywhere with the release of payment to **delivery partner** (incase if the certification fees is collected by **resource partner / College**).
10. Student would be receiving their **transcript and certificates** for the exam directly in their account in e-format, from the specific vendor like Microsoft /Oracle/Certiport etc. post successfully clearing the exam.
11. Resource partner / College would provide necessary infrastructure within college, like labs with Computers, LCD Projector's, internet etc. for the execution of the **free training** and conducting the **Certification Exam**.
12. Resource partner / College would allocate time slot either on weekends/holidays /regular slot for min 6-8hrs or as per mutual consent with delivery partner for execution of FREE training in their campus.
13. The duration of the training may increase as per the level of participants and shall not be linked with the release of payments.
14. The tenure of the contract would be for a period of three years i.e. from **12th Sep 2019 to 11th Sep 2022**, same cannot be terminated for min period of one year from the date of signing of the MOU.
15. Prices of the certification are subject to yearly review and revision as per the policy of the Certification vendor and other state and govt taxes as and when applicable by the Govt of India. However, a proper communication would be provided, whenever there is impact on the same.
16. "**Resource partner / College**" cannot hire or take services from any current full time /part time, ex- employee of the Delivery Partner either directly or indirectly for any fulltime or part time assignment for minimum period of one year from the date of expiry of contract.
17. "**Resource partner / College**" must follow from time to time rules/regulation & operational protocols laid down by Microsoft/Certiport other international vendors for their respective certification.

In case of any dispute, or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach there of shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties "however the court of jurisdiction would be Pune.
19. This **clause** is intended to be legally binding and the parties agree and acknowledge that both the terms of this **MOU** and the discussions relating to the collaborative activity are **confidential** and neither party will disclose them without the prior written consent of the other party.
20. **Resource partner / College** would issue a letter of completion upon successful completion of the certification and bundled training program.
21. Minimum batch size to run a free training/workshop bundled with Certification will be 50 students however in case the numbers are very less than the decision on the same would be as per mutual consent.
22. Cost for the Certification is Rs. 3696/- + GST however students will get the additional discount and they have to pay fees Rs. 2880/- + GST.
