1. The expression and thoughts of both the parties shall be final with respect to this MoU.
2. The purpose of this MoU is to enter into Collaborative Research with the Second party on the projects undertaken by Ms. Swathy Viswanath M., so that the research scholar can register for Ph.D at the Yenepoya (Deemed to be University), Mangalore, and work be done at both the institutions depending on the facilities available within the framework of UGC Regulations.

7. The MoU will come into effect on the day of approval by both, First Party and Second Party which will have duration of five years. Thereafter, it will be renewed as per the requirements.




