**The following are the conditions of the MOU**

1. CSBMM faculties provide consultancies for designing specific proteomic and metabolomics works for Aurigene. CSBMM will also provide services for mass spectrometry-based projects. Appropriate consultancy and service fees will be charged.
2. Aurigene will design the study in consultation with CSBMM Faculty, and CSBMM will prepare a quotation for service. Aurigene will then provide purchase order along with 50% advanced payment. Rest of the payment will be made after the data acquisition and analysis
3. Dr. Keshava Prasad and other scientists assigned by the Center will represent the CSBMM, and Dr. Thomas Antony and other scientists will represent Aurigene. They will supervise the above-mentioned service projects.
4. **Material.** The name and amount of the material being transferred to CSBMM are: Cell lysates.
5. **Research Plan.** The Material will be used by CSBMM in scientific research/evaluation as outlined in the attached Exhibit A (the "Research Plan").
6. **Use of the Material.** The Material shall not be used on human subjects. The Material will be used for no purpose other than described in the Research Plan and in compliance with applicable local laws.
7. **Confidential Information.** For purposes of this Agreement, the term "Confidential Information" shall mean the following: Any information, matter, intellectual property or thing of a secret, confidential or private nature connected with the business of individual Party, as the case may be, or any of their suppliers or customers, including but not limited to, with respect to individual party's patented and unpatented inventions, trade secrets, drawings, know-how, techniques, product plans, designs, software, hardware, data, financial information source and object code, formulae and concepts not reduced to material form, but excludes such information, as was in the public domain prior to such disclosure.
8. **Disclosing Party.** "Disclosing Party" means a Party that discloses Confidential Information under this Agreement. **Receiving Party.** "Receiving Party" means a Party that receives Confidential Information under this Agreement.
9. The Parties agree that any Confidential Information disclosed by any "Party" in accordance with the agreement and related to the Purpose shall be maintained in secrecy

1. **Publishing.** CSBMM shall not publish or will not make the results publicly available, whether by publication, or by including them in advertising, press releases, promotional material or otherwise.



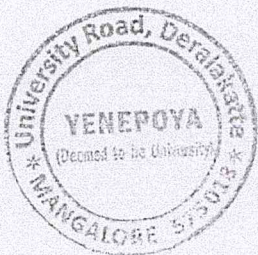

7. Any articles of the MOU may be modified or changed by mutual agreement of the parties hereto in writing. The modifications and changes shall be effective from the date on which they are made unless otherwise agreed to.
8. All disagreements, difference of opinion, disputes regarding the interpretation of the provision of this MOU shall be resolved by mutual consultation of the heads of the institute/company or their authorized representatives
9. Governing Law. This Agreement shall be governed by and construed in accordance with the Laws of the State of Karnataka in any suit or proceeding arising out of the subject matter of this Agreement.



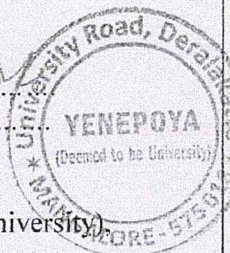


