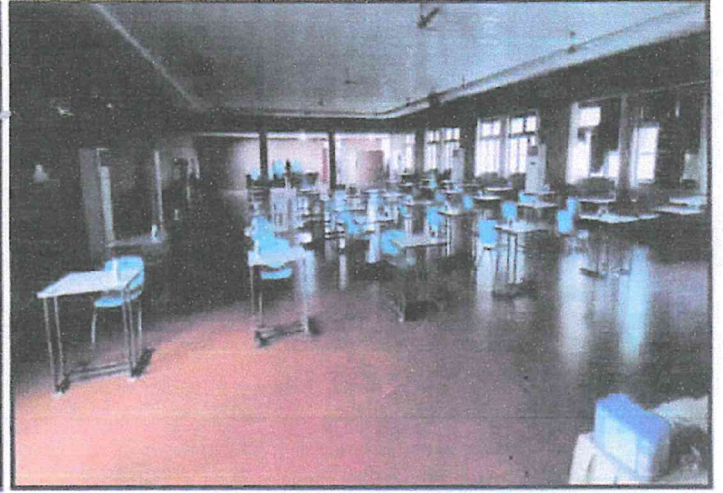
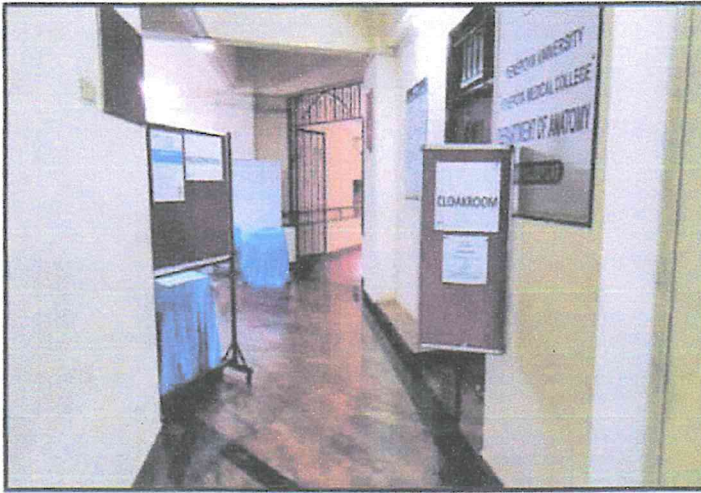

## LETTER OF INTENT (‘LOI’)

This LOI sets forth the areas in which PEAR Academy Australasia and Yenepoya University will collaborate to reach agreement and move to a binding Memorandum of Understanding (‘MoU’).

1. PEAR to deliver the OET English for Health Professionals (EHP) coaching program to students of Yenepoya University. PEAR may also deliver other coaching programs, including for IELTS.
2. The parties will consider embedding the OET EHP program in the curriculum of the Yenepoya University. This may be achieved through the adoption of the OET EHP program by Yenepoya University as a mandatory course module in its Certificate III program.
3. PEAR to establish an OET Test Centre at Yenepoya University.

### Memorandum of Understanding (MoU)

On reaching agreement on the areas outlined in this LOI, the parties will execute a binding MoU, which will set out the agreement reached by the parties on the above three areas; and, will include:

- The method of implementation and the operational requirements.
- Obligations of each party to ensure the maintenance and success of the implemented project.
- Management procedures to monitor progress and effectiveness.

### Scope of Collaboration

1. **The PEAR OET English for Health Professionals (EHP) & PEAR Academy Specialist IELTS Programs**
  - a) PEAR has developed, owns and delivers an OET EHP program, a specialist IELTS program and other English programs in stand-alone coaching centres and on-campus at universities around the world.

- b) The focus of the collaboration will initially be on the delivery of the OET EHP Program. The parties will also consider delivery of the IELTS program and any other English program that may be of benefit to students of Yenepoya University.
- c) PEAR and Yenepoya University intend that the OET EHP program will be delivered on-campus at Yenepoya University.
- d) The program will be made available to external medical and allied health students and professionals from other institutions and hospitals in Mangalore .
- e) The program will be endorsed by Yenepoya University and marketed regularly through traditional methods and social media to its students, faculty, and affiliated institutions.
- f) PEAR trainers will be responsible for course delivery initially
- g) Yenepoya University's English lecturers will undergo PEAR's 'Train-the-Trainer' program so that they may take over the course delivery on successful completion of the program.
- h) PEAR will provide support to Yenepoya University in its delivery of the OET EHP program.
- i) Yenepoya teachers to undergo PEAR's refresher courses for the OET EHP program to ensure continued professional development.

## 2. PEAR OET EHP Program Embedding


- a) The parties will consider the merits of the embedding of the OET EHP program by Yenepoya University as a unit in its Certificate III program and also whether program will be mandatory for students or an elective.
- b) If the parties decide that the OET EHP program will be embedded into Yenepoya University's Certificate III, the parties will agree to the terms of such embedding.

## 3. PEAR OET Test Centre at Yenepoya University

- a) PEAR is licensed by OET to operate examination venues for the OET test.
- b) Given the scope of the PEAR-Yenepoya collaboration, it is logical to extend this to providing candidates a mechanism to sit the test where they have prepared for it; and, where they are most comfortable in familiar surroundings. An OET test venue at Yenepoya University will save candidates a considerable amount of money, time, and days off work as they would not need to travel to other locations to sit the test.
- c) We believe strongly in enabling students to prepare and test in the one location.
- d) PEAR seeks to rent premises at Yenepoya University to conduct the OET examinations on a monthly basis. OET exams are conducted on weekends only. This will be subject to OET inspecting the premises to assess suitability.
- e) OET has a list of criteria that need to be met in order for an application to qualify as an OET test centre to be successful. PEAR provide these criteria to Yenepoya for assessment of a prospective site in the Yenepoya group of institutions.
- f) A Rental Agreement will be entered between PEAR Academy Australasia and Yenepoya University for the use of premises at Yenepoya University to conduct the OET tests.
- g) PEAR Academy-Yenepoya OET test centre in Mangalore will be the first OET test centre in Mangalore. We do not expect a licence to be granted by OET for a 2<sup>nd</sup> test

venue in Mangalore for a period of 18 months to 2 years. Each test venue is limited to a maximum of 200 candidates per test.

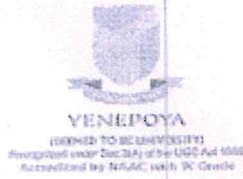
