



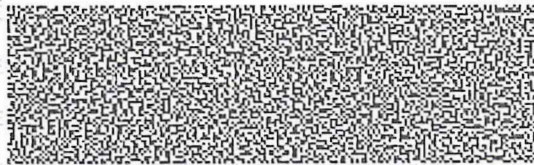
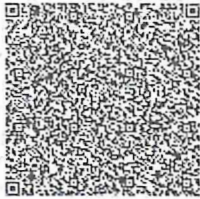

### 3.0. Responsibilities of the Company:

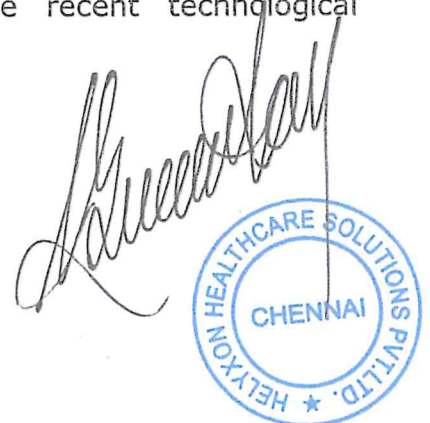


#### 6.0. Financial Commitment:

## 7.0. Confidentiality:

7.1. Both the Parties will protect the Confidential Information which may be received by a Party in pursuance of this MoU and keep confidentiality of the same with the same degree of care as each Party would take in respect of its own confidential information. The Parties will use such confidential information only to serve the purpose for which it was intended and furnished to the other Party.
