This MOU is made on 13th day of August, ~~2012~~ and executed between Yenepoya University, Deralakatte, Mangalore – 575 018 (First Party) and Research & Development Centre, Agappe Diagnostics Ltd., Agappe Hills, Pattimattom (P.O.) Dist. Ernakulam, Kerala – 683 562 (Second Party)

1. This expression and thoughts of both the parties shall be final with respect to this MOU.
2. This MOU has been made to enter into research collaboration with the Second party, so that research scholars can register for Ph.D at the Yenepoya University, Mangalore and work be done at both the institutions depending on the facilities available within the framework of UGC regulations.
3. Agappe Diagnostics Ltd. shall be one of the external private Research Centres of Yenepoya University for this purpose.
4. Research publications of the Ph.D candidates of Second Party will be under the First Party and the eligible teachers of R&DC will be shown as adjunct professors of Yenepoya University.
5. There will be no expenditure from the First Party side, as the research fund will be generated by the Second Party.
6. Persons working in the R&DC of the Second Party and holding M.Sc degree could work for Ph.D degree so as to enhance their career.

7. Ph.D candidates of Second Party will abide by the rules and regulations with regard to Ph.D programme and do course work prescribed by the Yenepoya University and will have personal interaction with the guides of First Party.
8. The agreement will come into effect on the day of approval by both, First Party and Second Party which will have duration of five years. Thereafter, it will be renewed as per the requirements.
9. The following action plan be taken:
 - a. Application by the R&DC to recognize the Centre by the Yenepoya University, along with the details of the Centre and the facilities available as well as biodata of potential Ph.D guides.
 - b. Visit of senior executives of the Yenepoya University to the R&DC to inspect the facilities available at the centre.
 - c. Recognition of the R&DC by the Yenepoya University authorities for research collaborations.
 - d. Recognition of the eligible co-guides available at R&DC by the Yenepoya University.
 - e. Registration of the Ph.D students as per the Yenepoya University rules.
 - f. Each Ph.D student will have one guide at the Yenepoya University and one co-guide from the R&DC.

- g. All of them should pass the preliminary examination conducted by the Yenepoya University within the prescribed time limit.
- h. All the rules of the Ph.D programme, as amended from time to time by the Yenepoya University will be applicable to these students at the R&DC.

That both the parties will endeavor to settle any controversy, disputes, differences or claims whatsoever related to this AGREEMENT including the existence, validity, interpretation, performance, termination or breach thereof, by arbitration through a sole arbitrator to be appointed by the "First Party". The Arbitration and Conciliation Act 1996, shall govern the arbitration proceedings. The arbitration will be in the Hon'ble Courts of Karnataka and the language of arbitration shall be English.

Both parties have read over the agreement and have clearly understood its terms and accept the same as binding IN WITNESS WHEREOF the parties hereto, have hereunto set and subscribed their respective hands the day, month and year hereinabove written.
