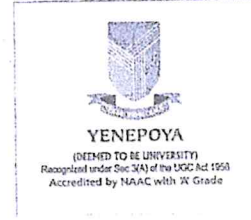

## TERMS OF REFERENCE

### CONTEXT:

KaraSeva (Name of NGO) is a registered non-governmental organization involved in early detection of common diseases in school children and provision of services to the elderly people by medical students. For the benefit of promoting health of the rural students and the elderly people in old age homes it seeks collaboration with RHCDC Yenepoya (Deemed to be University) for extension of health care and promotion activities. Hence this MOU has been executed.

### The following will be the roles and responsibilities of Directorate of Rural Health Care and Development Centre (RHCDC)

1. RHCDC shall coordinate screening activities at regular intervals in the schools, orphanages and old age homes selected by NGO based on physical feasibility [not exceeding 100 kms from Yenepoya (Deemed to be University)].
2. Cases referred from the schools, orphanages and old age homes will be provided treatment in Yenepoya Medical College Hospital (YMCH) in accordance with the regulations of the hospital regarding patients being referred from camps organized by YMCH.  
RHCDC shall assist in referral of patients. For this, volunteers of NGO (Kara Seva) and MSW department of Yenepoya (Deemed to be University) shall provide support.
3. RHCDC shall assist in imparting health education programmes in schools and old age homes selected by the NGO (KaraSeva).
4. RHCDC shall coordinate with Yenepoya (Deemed to be University) for providing transport facility for conducting field - based activities and referral of the patients to YMCH for further management.

**The following will be the roles and responsibilities of the NGO**

1. The list of students enrolled in KaraSeva should be submitted with their parent's consent letter to RHCDC, Deputy Director.
2. New students can be enrolled in KaraSeva only on a quarterly basis and the same should be informed to RHCDC, Deputy Director.
3. The NGO will identify the schools, orphanages and old age homes for conducting screening programs based on the physical feasibility [not exceeding 100 kms from Yenepoya (Deemed to be University)].
4. The NGO should seek permission letter from the Principal/ I/C Principal of school, in charge of orphanages and old age homes.
5. The NGO shall submit written request and details of activities planned in the respective institutions to Deputy Director, RHCDC every time for any outreach activity at least one week before the scheduled date of the camp.
6. List of students attending the camp should be submitted to RHCDC, Deputy Director at least 04 working days before the scheduled camp date and the same will be submitted to Principal/ Dean Yenepoya Medical College for further approval.
7. The NGO volunteers and members shall conduct health education, screening for visual acuity, dermatology, dental and psychiatric disorders and common ailments in the institutions, provided they are certified by the respective departments of Yenepoya Medical College Hospital (YMCH). The activities of NGO shall be undertaken on Friday afternoon after college hours.
8. The patients will be referred to YMCH for further management on outpatient or inpatient basis depending on the need. School children should provide consent forms of their parents to refer them to YMCH for further management.
9. Yenepoya Medical College Hospital (YMCH) shall provide medicines and other clinical services (chargeable as per policy of YMCH) on credit basis on request from the authorized representative of NGO. The NGO shall be responsible for clearing the credit bills, within four weeks.

10. NGO shall coordinate with the food kraft for arranging mini meals (not exceeding Rs. 1200/- per month) for the patients referred for treatment/ investigation on outpatient or inpatient basis to YMCH from the KaraSeva camps. The cost involved will be borne by Yenepoya (Deemed to be University).

### AMENDMENT AND ARBITRATION

This protocol shall be in effect for five years following the date of signature. This protocol may be complemented or amended by the written and common consent of authorized representatives of both institutions. The addenda or amendments will not be valid unless it is written and signed. The protocol may be extended as required by written and signed consent of the parties.

Any dispute arising out of or in connection with this agreement or in the event of any conflict of interpretation of this agreement, both the parties shall strive to amicably and mutually resolve the same in the good interest of all the stakeholders.

Each organization shall reserve the right to terminate the protocol by issuing a written notice three month in advance to the other party. In that case, on-going projects shall be completed.

This Memorandum of Understanding will come into force upon affixing of the signatures by both the parties and will remain in force until all the stipulated obligations are met from the day of signing this document.


