The objective of this proforma Early Detection and Management of four D's 1. Defects at Birth, 2. Deficiencies, 3. Diseases and 4. Development Delays & Disabilities. This unit is working in coordination with RBSK doctors. District Early Intervention Centre involved in all the activities of RBSK in screening camps and identify beneficiaries.

offer given by the Yenepoya Dental College a constituent college of Yenepoya Deemed to be University, to provide free services to cater these beneficiaries aged between 0-18 years for the comprehensive oral health care since the hospital does not have the faculty as of now from the Government.

#### **Role and Responsibilities of Yenepoya Dental College – First Party**

1. Regular Outpatient services will be offered by Department of Pedodontics and Preventive Dentistry, Yenepoya Dental College, on all working days of the hospital excluding government holidays, in the following schedule  
Monday  
Tuesday  
Wednesday  
Thursday  
Friday  
Saturday
2. On above mentioned days the designated team of faculty will be available to patients in the District early intervention centre, Wenlock district hospital between 9.00AM to 3.30PM for rendering Oral Health Care services.
3. The Faculty will take part in all the activities of District Early Intervention Centre services.
4. Faculty from Yenepoya Dental College shall provide services to the patients on Out Patient basis and will frame guidelines for the treatment of patients depending upon nature of illness. The treatment to such patient shall be as per NOHP guidelines/STG.
5. The first party agrees to provide free OPD consultation as well further management of the patients.
6. The first party shall ensure that the best and complete diagnostic, therapeutic and follow-up services based on standard protocols and dental practices/recommendations are extended to the beneficiary. It is also mandatory for the Provider to assess the appropriate need and subject the beneficiary for treatment/procedure free of cost without causing any burden to Second Party. The treatment will be followed as per guidelines from department of Health & Family Welfare. The First party will be accountable/responsible for all the legal issues regarding treatment and management.
7. The first party agrees to render complete oral health needs for children which would include oral screening, oral prophylaxis, restoration, pulp therapy & extraction.
8. All the equipments, instrument and logistics required will be provided by the First party.
9. With the anticipation of the permission from the achieved authority (MD, NHM) This MOU is done

**Responsibilities of District Early Intervention Centre, Govt. Wenlock Hospital  
Dakshina Kannada District, Mangalore – Second Party**

1. The District Early Intervention Centre should provide facilities in terms of consultation rooms with water and electricity connection for operation of Dental services.
2. For grievances if any the chief Functionary of 2<sup>nd</sup> party shall submit a written complaint to the Dean Yenepoya Dental College for verification and redressal.
3. TERM: The term of this agreement shall be for 5 years/ or till the faculty appointment from the government and shall renew unless terminated within the terms of this agreement.
4. MODIFICATION: Changes to this MOU/MOA may be made only by written agreement by both parties.

**CONFIDENTIALITY:**

All stakeholders undertake to protect the secrecy of all the data of beneficiaries and trade or business secrets of, and will not share the same with any unauthorized person for any reason whatsoever within or without any consideration.

**AMENDMENT AND ARBITRAION**

Amendment, if any, to this MoU, can be made mutual consent of the two parties on writing only.






This MoU may be terminated by either party by giving three months prior written notice by means of registered letter or a letter delivered at the office and duly acknowledged by the other.
