





STAFF

The staff employed on the research scheme will be council's employees but for all purposes be treated as employees of the Institute and will be accordance with the normal recruitment rules and provisions of the institute.

The scales of pay, allowance etc, are liable to the staff of the schemes will be the same as admissible under the rules of the grantee institution. Prior approval of the Council will however be necessary if pay higher than the admissible under the rules of the institution is sought to be given by grant of advance increments.

The Council will not be liable to bear any expenditure pension/provident fund contribution and or leave salary contribution incurred or committed by the grantee for persons appointed on deputation from any other organization.

REPORT OF WORK DONE

The grant is being sanctioned on the condition that reports on the programmes of work done on the research scheme will be submitted to the Council as and when called for normally a progress report of work done on the enquiry will be submitted to the Council and when required. The enquiry may be discontinued immediately unless there is sufficient justifications for non-submission of the report of work done on the enquiry.

PUBLICATION

The financial assistance rendered by the Council be acknowledged in any published account of work for which the grant is given. A list of papers published based on the work carried of enquiry under the auspices of the ICMR shall be submitted annually alongwith reprints of the papers. Prior permission of the Council shall be obtained before publication of any such papers in the foreign journal.

PATENTS

The Council shall have be right to take out patents in respect of invention/discoveries made under scheme/project financed by the Council. The officer-in-Charge of the staff employed in ICMR scheme shall not apply or obtain patents for any invention/discovery made by them without approval of the Council.

All the patents will be registered in the name of the Indian Council of Medical Research, New Delhi.

TERMINATION OF THE ENQUIRY

Sir,

The Director General of the ICMR sanctions the budget of Rs.11.10,000/- [Rupees eleven lakhs ten thousand only] with effect from 1.8.2018 to 31.7.2020 subject to the conditions that the grant will be released to the Head of the Institute during the financial year on receipt of the demand in the prescribed form [Appendix-I] as indicated below

While asking for the release of the instalment it may be used that the amount for the pay and allowances of the staff who are actually in position is included.

A separate account for the grant received and expenditure incurred shall be maintained. The account will be subject to audit by the authorized auditors of the institution. In case, facilities are not available for such auditing, the accounts will be audited by the Council's own internal auditors, latest by the end of December following the financial year for which the grant is paid and audit certificate from the auditors to the effect that the account have been audited and that the money was actually spent on the objects for which it was sanctioned shall be submitted to the Council along with a list of non-expendable articles purchased out of the grant during the year. Any unspent balance would be refunded to the ICMR on termination of the scheme. Further grant will be stopped unless audited statement of accounts and utilization certificate received within a period of the year after the end of the financial year for which grant was sanctioned.

The last instalment of the grant will be paid on receipt of the audited certificate which will include all the liabilities of last year, expenditure incurred before or defrayed after termination of the scheme. The year to which the expenditure pertains should be shown clearly.

The grant will not be regarded as a subvention, towards the normal work of the institution but should be exclusively utilized for the research activity for which it has been sanctioned.

Expenditure should on no account exceed the allotment sanctioned for the enquiry. Expenditure incurred over and above the sanctioned amount against one or more sub heads of expenditure such as pay, allowance, contingencies etc. shall be met without reference to the ICMR by re-appropriation of saving under remaining subhead provided that the total expenditure incurred during the financial year.

No expenditure shall however be incurred by re-appropriation of saving on items not sanctioned by the Council i.e. non consumable equipment, stores not sanctioned by the Council saving shall also into be re-appropriate for meeting on incurring expenditure on shall that has not been sanctioned by the Council.

The grant paid by the Council shall be refunded in full by the institution if and when the grantee sanctioned discontinues scheme midway or does not follow the detailed technical programme laid down and approved. Receipt realized by the project officer on behalf of ICMR project, if any, will be remitted to the Council as misc. receipt and not utilized for meeting expenditure of the project. All facilities for the conduct of the research scheme basic equipments and laboratory chemicals, glassware, furniture and other assistance, as may be required for the smooth working of the research scheme, shall be provided by the host institute. The stores purchased out of the grant of the Council shall be entered in the project stock register and presented to auditors for check and endorsement. All purchase to the made in accordance with the procedure in vogue in your institution.




