



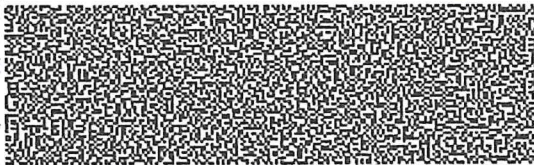
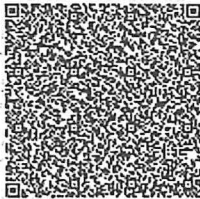


2. TERM

3. TERMINATION

relating to the business, accounts, finance, contractual arrangements of intellectual property (whether owned or licensed by the parties), marketing or promoting of any product or services, business policies or practices, customers, potential customers or documentation or other dealings, transitions, affairs or property of the Company which may come to his/her knowledge and she/he shall use all reasonable endeavors to prevent the publication or disclosure of any confidential information concerning such matters.

- 11.2. For all disputes which are referred to arbitration, both parties will jointly decide to have an arbitrator or arbitrators acceptable to both. No officer, director, shareholder, employee, representative or Related Party of both Parties shall be nominated or appointed as an arbitrator. All arbitration proceedings shall be conducted in the English language and the seat and venue of arbitration shall be Bangalore, India. The courts of Bangalore shall have exclusive jurisdiction over any matters that are ancillary to the maintenance, prosecution, and support of the arbitration proceedings mandated hereby, and the Parties hereby submit to the jurisdiction of the said courts for such matters. The arbitrators shall decide any such dispute or claim strictly in accordance with the governing law of India.
- 11.3. The arbitral award shall be substantiated in writing and the Arbitration Board shall also have the right to decide on the costs of arbitration proceedings. Any award made by the Arbitration Board shall be final and binding on each of the Parties.
- 11.4. Subject to the award of the Arbitration Board, neither the existence of any Dispute nor the fact that any arbitration is pending hereunder shall relieve any of the Parties of their respective obligations under this Agreement and

The Parties expressly agree that this Agreement was jointly drafted, and they both had opportunity to negotiate its terms and to obtain the assistance of counsel in reviewing its terms prior to execution. Therefore, this Agreement shall be construed neither against nor in favor of either Party but shall be construed in a neutral manner.

14. AMENDMENTS:

All changes and amendments to this Agreement or to any attachment thereto are valid only if made in writing and signed by duly authorized representatives of both the Parties.

15. COUNTERPARTS:

This Agreement may be executed in two counterparts and each counterpart shall be treated / deemed as original.





