### **Sub: Creation of a new Centre titled "Quality Assessments & Compliance Cell" under the University.**

In view of the increasing number of institutions and also different agencies such as NAAC, UGC etc., visiting regularly for assessing the quality of the University coupled with the other apex bodies such as MCI, DCI, INC etc., visiting for frequent inspection, need for creation of a separate cell for coordinating, liasoning, facilitating & executing such matters with a full time leadership was urgently felt. The new centre will be titled "Quality Assessment & Compliance Centre". The existing IQAC cell will be merged with this new centre.

As the said needs to be urgently implemented the Vice Chancellor by exercising his powers vested on him as per Byelaw YU 440-B(a) has approved the creation of a new centre Quality Assessments & Compliance Cell with immediate effect.
