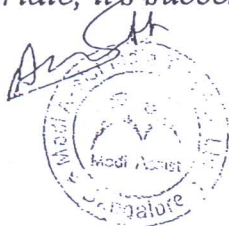

Medi Assist and Hospital are hereinafter, wherever the context so admits, collectively referred to as the "Parties" and individually as a "Party".

Whereas:-

Medi Assist is a Licensed Third Party Administrator, licensed by the Insurance Regulatory Development Authority, Hyderabad, vide License No. 003 dated March 21, 2002, and is engaged in the business of providing Third Party Administration" services for certain insurance companies in connection with "Health Insurance Business" or 'Health Cover' as defined in regulation 2(f) of the IRDA (Registration of Indian Insurance Companies) Regulations, 2000. Authorized by the National Insurance Company for implementation and servicing of the RSBY policy.

2. *The Hospital is an organization involved in the business of providing health care services to the public.*
3. *The Parties, pursuant to mutual discussions, are desirous of entering into this Agreement pursuant to which the Hospital would provide "in-patient" Medical and/or Surgical treatment to Approved RSBY members and the ^{I.T}~~National~~ Insurance Company would reimburse the charges of the Hospital for the provision of such "in-patient" medical and/or surgical treatment, subject to the terms and conditions of this Agreement. For the purposes of this Agreement, "RSBY Members" mean those individuals, who have been enrolled under RSBY scheme to avail medical facilities for treatment as per RSBY guidelines a Mediclaim policy from an insurance company and in connection with whom Medi Assist has entered into agreement(s) with such insurance company and/or the individuals for the provision of third party administration services by Medi Assist.*

Now this Agreement witnessed as follows:

1. Term:-

- 1.1 *This Agreement shall be in force and effect for a period of 1 (one) year or till the expiry of policy as and when done by Insurance company, with effect from ____2011 subject to its earlier termination in accordance with this Agreement, and may be renewed or extended further on such terms and conditions as depending upon the directives of Govt/ Insurance companies be enrolled under RSBY. All the terms and conditions are governed as per RSBY Guidelines which is available in the www.rsby.in*
