

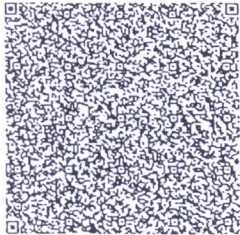



TERMS, CONDITIONS AND COMPENSATION

WHEREAS Yenepoya University seeks to recruit qualified students for the programs offered at its campuses in India:

Yenepoya University

WHEREAS, Yenepoya University desires to engage the services of qualified and reputable recruitment sources or agencies to engage in such recruitment activity on its behalf; and,

WHEREAS, Yenepoya University desires to enter into an agreement to provide agent the right to recruit such students for the Yenepoya University under following conditions:

The agent will recruit students make necessary arrangement to travel to India and students shall attend for the final interview for the selection in Yenepoya University to B.Sc. Nursing and Physiotherapy course. The agent will be responsible to provide all necessary documents to ensure that the students will enter the campus legally for the period required to complete the program of study. All travel costs shall be borne by the student.

Yenepoya University will provide the appropriate documentation verifying all the documents and admit students subject to the availability of the seats. The University will arrange hostel for the students during their program of study.

Students attending Physiotherapy and Nursing programs shall pay tuition fees and other admissible fees at the rate currently in existence at the time of signing the enrollment agreement.


TERMS OF PAYMENT: Students must pay the installment of tuition fee as per the schedule provided.

THE UNIVERSITY shall pay the Consultation Fee to Agent/Coordinator at Rs.25000/- per student after the receipt of the **1st Year Fees in full** from Nepalese students and that the students have started attending the course of study for at least 30 days.

The tuition fees and other related fees charged by the University will include all academic and University fees. This does not include examination fee which will have to be paid before filing application for examination.

The hostel rent does not include food charges and hostel establishment charges which is charged at actuals and to be paid by the student every month.

As the Nepalese representatives of the University shall execute a separate agreement with the student and the parents/guardian agreeing to pay the entire course fee in case the students withdraw from the course before the completion of the course.
