

MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING is entered into on this 1st day of September 2014, by and between:

RANGNEKAR INSTITUTE OF MANAGEMENT STUDIES AND RESEARCH, Indian Affiliate of Brenau University, Georgia, USA, an educational institution registered under the Indian Trusts Act 1882 and having its registered office at # 716/35, II Floor, JC Plaza, III Block, 12th Main, 42nd Cross, Rajajinagar, Bangalore 560010, Karnataka, affiliated to BRENAU UNIVERSITY, located at # 500, Washington Street, SE, Gainesville, Georgia, 30501, USA, which is accredited by Southern Association of Colleges and Schools (SACS), and Accreditation Council for Business Schools and Programs (ACBSP), which are reputed accrediting bodies of educational institutions in the United States of America, and is a Registered Education Provider (REP) of the Project Management Institute (PMI), located at #14, Campus Blvd, Newtown Square, PA 19073-3299, USA, and also recognized by the UGC, Government of India, represented by its Director, Harsha K C, and Brenau University Program Director, India Operations, by Dr. S.S.CHANDRASHEKAR, Hereinafter referred to as RIMSR for brevity's sake (which term shall mean and include its successors, assigns etc.).

AND

Yenepoya University, Mangalore, a Deemed to be University under the UGC Act 1956, Govt. of India, represented by its Registrar, Dr. C.V. Raghuvier, hereinafter referred to as Yenepoya University for brevity's sake (which term shall mean and include its successors, assigns etc.).

WHEREAS RIMSR is an established educational trust set-up with the objective of establishing management institutions, colleges, centers for management studies and research and to achieve this objective it may become an affiliate of an Indian University/Foreign University and conduct such programs of the Universities so affiliated to. RIMSR is offering Post-Graduate Programs in Business Management, Healthcare Management, and Project Management along with Post-Graduate Certificate Programs in specialized areas.

WHEREAS Yenepoya University is an Educational Institution with a vision to provide access to quality higher education, ensuring equity, to create a vibrant knowledge capital and to create inspiring leaders of tomorrow who can take this country to the forefront of the developed nations to emerge as a World-Class Institute endeavoring to be the pinnacle in Medical Education in India and with a mission to impart quality education to the students.

01 OBJECTIVE

1.1 WHEREAS both RIMSR and Yenepoya University are desirous of extending to the students of their group colleges opportunities of getting Advanced Certificate in Healthcare Management, MBA in Healthcare Management, both the Institutions mutually collaborating with each other with a view to offer such value-addition Healthcare Management Program/s to the students of the college. To achieve the said desired goal, the parties have, after discussion, agreed to reduce the understanding arrived at between them into writing detailing the regulations of the Advanced certificate in Healthcare Management Program and MBA in Healthcare Management to make the venture a success, and beneficial to the students in specific, and to the society at large.

1.2 The essence of this Memorandum of Understanding between RIMSR and Yenepoya University shall be integrity, ethical practices, and scrupulous adherence to the laws of the land and above all mutual trust and respect for each other.

02 NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES:-

In consideration of the mutual benefits accruing to both the parties from the association, it is agreed to adhere to the regulations as follows:

- 1) These regulations are applicable for the students pursuing the Post-Graduate, Graduate programs in Medical, Dental, Nursing, Physiotherapy & other equivalent/ related disciplines, as well as professionals who have completed their graduation and are planning to enter into the field of Healthcare Management.
- 2) The Advanced certificate Program in Healthcare Management shall be conducted under the direction/s of Brenau University-RIMSR and Yenepoya University strictly in accordance with the prescribed curriculum, rules, norms, and standards of Brenau University and Yenepoya University jointly.
- 3) RIMSR is responsible for the delivery and maintenance of quality of the program which shall be monitored by Brenau University and Yenepoya University
- 4) RIMSR is responsible for grading and evaluation of all assessments/examinations under the directions of Brenau University and Yenepoya University.
- 5) This MoU also covers the MBA program in Healthcare Management which is of 18 months duration on virtual learning platform supported by RIMSR with on-campus tutorials, conducted by Brenau and Yenepoya Universities jointly.
- 6) The course work consists of e-learning, on-ground proctoring, lectures, workshops, seminars, symposia, exercises, case-study discussions, podcasts, webcasts, webinars, industrial/ hospital visits, and library research, as updated from time to time by RIMSR/ Brenau University and Yenepoya University.
