YU-IAEC MEETING NOTIFICATION

The Institutional Animal Ethics Committee meeting [IAEC] of Yenepoya (Deemed to be University) will be held tentatively in the second week of September 2022(or before) to review all animal related research projects.

Interested Faculty/Ph.D Scholars/PG students/ UG students may submit their research protocols involving small laboratory animals both in soft copy [[to-iaec@yenepoya.edu.in](mailto:iaec@yenepoya.edu.in)] and hard copy for approval to the undersigned on or before 3rd September 2022. The proposals should be submitted in the format given by CPCSEA, which can be downloaded from Yenepoya (Deemed to be University) website.

Submission should include –

- Revised Form B (Part A, Part B, Investigator's declaration and certificate page) all the pages should be completely filled and duly signed by the researcher and in case of PhD/PG/UG student project/thesis, it should include signature of the respective guides.
- Complete protocol of the animal related study (Introduction/ Background, Review of Literature in brief, Methodology, Statistics and References).
- Approval certificate from the YU-IAEC Subcommittee. *
- In case of renewal/ extension/ Protocol change/ Title Amendment, Covering letter addressing the Chairman of IAEC with valid reason and supporting documents.

Documents should be submitted both in hard copy and soft copy.

The documents should be saved as Revised form B_ PIs name and Protocol_PIs name and mailed to iaec@yenepoya.edu.in.

Those investigators whose IAEC approval has been granted with the clause to submit their preceding year results to obtain next batch of animals are also requested to submit their report to the undersigned on or before 3rd September 2022. Incomplete forms and submission after the deadline will not be accepted.
